Feedback analysis : Feedback analysis of above Table for the academic Session 2021-22. 30% of alumnus have responded that different components of curriculum prescribed during the course, quality of education, course content delivery i fulfilling expectations, academic initiatives taken, new shift development programme other than syllabus, relevance of degree with present tob, development activities and motivation for higher study found excellent, followed by 35% very good, 34% good. However only 1.5% of alumnus has rated different components of the curriculum average and recommended improvement in it. As per the response of alumnus it reveals that the Board of Studies at University level and teachers level has put their best efforts in the designing and implementation of curriculum.
